### Welcome to Treasure Coast Builders Association's 2022 Parade of Homes.

The Parade of Homes is an annual event designed to promote our local builders and their products. This is a scattered site parade, and you may enter any model home or unoccupied spec home, located in Martin, St. Lucie, Okeechobee or Indian River County.

Extensive promotion and advertising is used to help you, the builder, drive traffic to your models.

#### All this is included in your entry fee:

- ◆ The entry fee for TCBA members is \$2,500 for the first model, \$2,100 for 2nd model, or \$1,900 for each additional model. Non-member fees includes membership and is \$3,000 for the first model, \$2,600 for 2nd model, or \$2,400 for each additional model. Entries and fees are due by *January 28, 2022*. Late entries will not be accepted.
- ◆ Judging will be held on *Saturday, March 26 2022 between 9am and 5 pm.*
- ◆ Realtor Day will be Thursday, *March 31, 2022*. Models on the route are requested to provide refreshments and a door prize. If you would like to participate in Realtor Day. Initial Here \_\_\_\_\_
- ◆ Each Parade entry must be open and manned by the builder or his representative during your designated Parade hours. We strongly urge the Builder to be present on *3/26* during the judging of the models to answer any construction related questions asked by the judges.
- ◆ Uniform signs for each model will be provided by the Treasure Coast Builders Association. The Parade of Homes model sign should be placed directly in front of the model for easy identification.
- ◆ Newly constructed models must be completed two days prior to the opening of the Parade. Models are not required to be decorated or furnished. Judging criteria pertain to models only, not furnishings.
- ◆ All entrants acknowledge that the awards given by the Treasure Coast Builders Association 2022 Parade of Homes is not an endorsement of the entrant or any of its homes, buildings, projects, products or services, and the entrant agrees to include the following statement in any promotional materials referencing the awards and any contracts involving award winning projects.
